PREAMBLE

- A. The Last Fling is a Naperville community event organized and coordinated by the Jaycees for the benefit of the community that it services.
- B. In conjunction with the Jaycees, the Vendor agrees that event attendees will not be persuaded in any way to take handouts or sign up for services.
- C. The Jaycees and Vendor desire to assure the community that they have adequate insurance coverage in the event that an injury or accident arises in connection with the Last Fling.

Now, Therefore, in consideration of the mutual promises contained herein, sufficiency of which is acknowledged, the parties agree as follows:

1. Vendor Spaces: The Jaycees agree to provide Vendor with a 10'x10' space in our Family Fun Land area at Naper Settlement. This space will be to promote the business of the Vendor. The Jaycees will provide a tent, table and two chairs to the vendor for use during the event. Additional tables and chairs can be rented for an additional charge, please specify below.

- 2. Payment: The Vendor agrees to pay the Jaycees a fee of \$1200.00 for each 10×10 space.
- 3. Electrical: The Jaycees will supply electricity to each space for one 110 volt, 15 amp circuit (four outlet). Should the vendor require an additional 110 volt, 15 amp circuit, the Vendor agrees to pay an additional flat fee of \$250.00 for each additional 15 amp circuit of additional electricity. Any electrical requirements in excess of those included with space shall be paid for by the Vendor, and provided by the Jaycees. All electrical fees shall be paid along with the final installment of the space fee.

Any additional electrical that is ordered late or on the weekend of the Last Fling, will be charged to the Vendor at the rate of \$300 per quad outlet, payable prior to connection, <u>if it is available</u>. If Vendor exceeds its electrical need, it shall be liable for any damages caused, including consequential damages.

- 4. Hours of Operation. The Vendor agrees to comply with the following time schedules for the operation of its booth space.
 - a) Set up time for Vendor shall be between 11:00 a.m. and 7:00 p.m. on Friday, September 4, 2009 and take down after 6:00 p.m. on Sunday, September 6, 2009. Additional set up time will be between 7:00 a.m. and 8:30 a.m. on Saturday, September 5 and Sunday, September 6. For set up, please use the entrance off S. Webster St. (big double gate about ½ block south of Aurora Ave.)

PLEASE NOTE: We ask that all vendors planning on using the Friday set-up time, please contact Eric Sunila at (630) 267-3343. It may be easiest to deliver the "hardware" for your booths on Friday, and do product drop off in the hours prior to the event on Saturday and Sunday.

b) Event Hours. Vendors may not operate any vehicles on the Family Fun Land Grounds during the following days and hours. We recommend using a cart or wagon to transport materials during this time.

Saturday 8:30 a.m. – 6:15 p.m. Sunday 8:30 a.m. – 6:15 p.m.

c) Vendor agrees to be open for the following days and hours:

Saturday 10:00 a.m. – 6:00 p.m. Sunday 10:00 a.m. – 6:00 p.m.

- 5. Vendor Items: The Vendor agrees that all handouts, raffle items, or service sign ups are detailed on the exhibit A to this agreement.
- 6. Miscellaneous: The Vendor also agrees to:
 - a) Provide its own banners or posters identifying its operation and abide by the Jaycees regulations regarding placement and size of such banners or posters. Banners may not be hung from the tent;
 - b) To wear uniforms, hats or other items of clothing to help identify the person involved in Vendors operation.
 - c) To remain inside their tent area. Vendors will not be allowed to stand outside their tent to obtain attention of the event attendees.
 - d) To not sell products but have people sign up for services and/or subscriptions. Samples can be handed out as long as they are sample sized, packaged, and are not beverages.
 - e) Provide the Jaycees a copy of a proper City of Naperville permit if any item(s) are to be raffled off.

- f) To clean and secure the Vendor space each night.
- g) To comply with any other rules or regulations established by the Jaycees for Family Fun Land Business Expo Vendors at the Last Fling.
- 7. Insurance: The Vendor agrees to provide to the Jaycees upon submission of this application, a current certificate of insurance which shall be effective for the dates of the Last Fling, and which will provide for coverage which shall include but not be limited to general liability coverage in the amount of at least \$1,000,000 (One Million Dollars), including a waiver of subrogation, and 30 days cancellation notification. The Naperville Jaycees, the Naperville Community Charitable Organization, Inc., the City of Naperville, Naper Settlement, and Naperville Heritage Society and the Naperville Park District shall be included on said certificate as additional insured's.
- 8. Liability: The Vendor agrees to pay for any damage done by it or its agents and employees to any personal or real property (e.g., tents, tables, streets, etc.) provided by the Jaycees to the Vendor at the Last Fling.
- 9. Failure to Perform: The Vendor agrees that all moneys deposited with the Jaycees are non-refundable, and that any failure on the Vendors part to comply with this agreement shall be a breach of this agreement, and the Jaycees shall be entitled to cancel this agreement and retain all moneys deposited as liquidated damages for the Vendors failure to comply with this agreement.
- 10. Indemnification: The Vendor agrees to indemnify the Jaycees, the Last Fling Committee, the Naperville Community Charitable Organization, Inc., any officer or member of the Jaycees, the City of Naperville, Naper Settlement, and Naperville Heritage Society and the Naperville Park District from any expense incurred by them in connection with any claim, lawsuit, or proceedings arising out of or in connection with any act or omission of the Vendor of its agents in connection with the Vendors involvement with the Last Fling.
